2. An Expert Team conducted onsite evaluation of the programs from **29th to 31st October, 2021**. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted accreditation for 3 years. **P. A. Polytechnic College, Palladam Road, Puliampatti, Pollachi, Coimbatore- 642002, Tamil Nadu** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **P. A. Polytechnic College, Palladam Road, Puliampatti, Pollachi, Coimbatore- 642002, Tamil Nadu** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
